- 2. Consider and determine changes to the registers and restrictions in the Traffic Bylaw and Speed Limit Bylaw, including hearing any submissions relating to those proposed changes.
- 3. Hear and determine matters arising under current bylaws and policies, including applications for dispensation from compliance with the requirements of bylaws or policies, unless such matters are otherwise delegated by Council.
- 4. Hear and determine other matters that require hearings or submissions, as referred by Council or other Committees.

### The Committee is delegated the following powers to act:

- Approval of matters determined by the Committee within its Terms of Reference.
- Approval of the establishment of hearings panels and their terms of reference.

## The Committee is delegated the following recommendatory powers:

- The Committee may make recommendations to the Council.
- The Committee may make recommendations to Committees.

### **Special Notes:**

- The Committee may request expert advice through the Chief Executive when necessary.
- The Committee may appoint additional members for hearings where the relevant terms of reference specify the requirement for expert or external representation.

# 6. Korikori Green Proposal to Declare a Pedestrian Mall Submissions

**Mark Jessen** spoke to their submission noting their support of the proposal concerning current pedestrian use and the existing infrastructure. He responded to questions from Members concerning current traffic use of the area.

**Geoff Kreegher** spoke to their submission noting their opposition to the proposal concerning the existing designation as a road, alternative routes, safety concerns and costing. He responded to questions from Members concerning traffic congestion and costing.

**Sarah Tapping** spoke to their submission noting their opposition to the proposal concerning traffic congestion on alternative routes. She responded to questions from Members concerning school traffic congestion, alternative modes of transport, and alternative options.

The Operations Team Leader took the report as read noting the consultation process and submissions received. She responded to questions from Members concerning usage of pedestrian malls, historical designation of Korikori Green, existing infrastructure, school traffic congestion throughout Hamilton City and mitigation plans, and road safety incidents.

# Purpose - Take

- 1. To seek approval from the Hearings and Engagement Committee for temporary road closures associated with the following events:
  - Sky Super Rugby Aotearoa Competition 2021; and
  - 2021 Super Rugby Trans-Tasman Competition.

- 2. That the Hearings and Engagement Committee:
  - a) receives the report;
  - b) approves the closure of the following roads to accommodate the events listed below:
    - Sky Super Rugby Aotearoa Competition 2021 and 2021 Super Rugby Trans-Tasman matches on 8 May 2021, 28 or 29 May 2021, 11 or 12 June 2021 and 19 June 2021 the following roads will be closed:
    - (i) Abbotsford Street (from Willoughby Street to Tristram Street) 4.00pm to 11.00pm
    - (ii) Tristram Street (from Abbotsford Street to Mill Street) 4.00pm to 11.00pm
    - (iii) Seddon Road (from Gate 5 to Mill Street) 4.00pm to 11.00pm
    - (iv) Mill Street (from Norton Road to Willoughby Street) 6.00pm to 11.00pm
    - (v) Liverpool Street to Vialou Street 6.00pm to 11.00pm
    - (vi) Tristram Street from Mill Street to Rostrevor Street 6.00pm to 11.00pm
  - c) approves the Notice of Decision be issued stating Council's decision to close the following roads to accommodate the events listed below:
    - Sky Super Rugby Aotearoa Competition 2021 and 2021 Super Rugby Trans-Tasman matches on 8 May 2021, 28 or 29 May 2021, 11 or 12 June 2021 and 19 June 2021 the following roads will be closed:
    - (i) Abbotsford Street (from Willoughby Street to Tristram Street) 4.00pm to 11.00pm
    - (ii) Tristram Street (from Abbotsford Street to Mill Street) 4.00pm to 11.00pm

- (iii) Seddon Road (from Gate 5 to Mill Street) 4.00pm to 11.00pm
- (iv) Mill Street (from Norton Road to Willoughby Street) 6.00pm to 11.00pm
- (v) Liverpool Street to Vialou Street 6.00pm to 11.00pm
- (vi) Tristram Street from Mill Street to Rostrevor Street 6.00pm to 11.00pm

# **Executive Summary - Whakaraapopototanga matua**

- 3. Applications have been received for temporary road closures to accommodate the following events:
  - Super Rugby Aotearoa 2021 (8 May 2021, 28 or 29 May 2021 and 11 or 12 June 2021)
  - Trans-Tasman Rugby match (19 June 2021)
- 4. These applications for road closures were not submitted within the 42-working day timeframe required for processing under the Transport (Vehicular Traffic Road Closures) Regulations 1965, and therefore approval under the Local Government Act 1974 is being sought.
- 5. There have been ongoing changes to the Sky Super Rugby Aotearoa 2021 Competition (Super Rugby) and 2021 Super Rugby Trans-Tasman Competition (Trans-Tasman) programmes throughout 2021 to work around the impacts of COVID 19. This has resulted in new draws and games being set.
- 6. Similar closures of these streets have been undertaken in the past. Consultation with adjacent property owners has been undertaken by the event organisers.
- 7. Staff have undertaken consultation with NZ Police and Waka Kotahi NZ Transport Agency, and both have approved these closure requests.
- 8. Staff consider the decision in this report has low significance and that the recommendations comply with Council's legal requirements.

# Discussion - Matapaki

- 9. The applications for the road closures associated with the following events were not submitted to Council in time for it to be processed under the Transport (Vehicular Traffic Road Closures) Regulations 1965 which requires 42 days public notice.
- 10. Approval of a temporary road closure for an event can be granted under the Local Government Act 1974 No 66, Schedule 10, Clause 11(e) by the Hearings and Engagement Committee.
- 11. The Sky Super Rugby Aotearoa 2021 Competition (Super Rugby) programme was set in October 2020 for the 2021 season. Due to the uncertainty of COVID 19, the original programme did not include any international teams. A new draw for Super Rugby, which included Australian games, was received in December 2020 and has resulted in a change to the details for the Chiefs matches at the FMG stadium.
- 12. There have been ongoing changes to the Sky Super Rugby Aotearoa 2021 Competition (Super Rugby) and 2021 Super Rugby Trans-Tasman Competition (Trans-Tasman) programmes throughout 2021 to work around the impacts of COVID 19.
- 13. While road closures for the majority of the matches were able to be advertised under the provisions of the Transport (Vehicular Traffic Road Closures) Regulations 1965, there are now four possible matches which have missed the 42-day public notice deadline.

- 14. Currently the Super Rugby has the final game programmed for 8 May 2021. Following the win by the Chiefs against the Crusaders on 17 April 2021, there is a possibility that this may be hosted by FMG Stadium Waikato so approval for an additional road closure is required.
- 15. If the travel borders remain open and the Trans-Tasman competition continues as planned, then approval of an additional closure for 19 June 2021 for the final match is required. All other games have already had their road closure notices processed (22 May 2021 and 5 June 2021).
- 16. Super Rugby have developed plans for a third round of matches as a contingency if travel borders close due to COVID 19 and the Trans-Tasman competition is not able to be completed. Additional dates of 28 or 29 May 2021 and 11 or 12 June 2021 are proposed to accommodate this third round, with the finals for the Super Rugby to be held on 19 June 2021 (instead of the Trans-Tasman final on this date).
- 17. If there are any changes to the details of these games outlined above, a verbal update will be provided at the meeting.
- 18. The details for the road closures are:
  - i. Abbotsford Street (from Willoughby Street to Tristram Street) 4.00pm to 11.00pm
  - ii. Tristram Street (from Abbotsford Street to Mill Street) 4.00pm to 11.00pm
  - iii. Seddon Road (from Gate 5 to Mill Street) 4.00pm to 11.00pm
  - iv. Mill Street (from Norton Road to Willoughby Street) 6.00pm to 11.00pm
  - v. Liverpool Street to Vialou Street 6.00pm to 11.00pm
  - vi. Tristram Street from Mill Street to Rostrevor Street 6.00pm to 11.00pm

#### Financial Considerations - Whaiwhakaaro Puutea

19. All costs associated with the two public notices required by the Local Government Act and temporary traffic management are met by the applicants.

### Legal and Policy Considerations - Whaiwhakaaro-aa-ture

20. Staff confirm that proposed approval complies with the Council's legal and policy requirements and those of the Local Government Act 1974.

# Wellbeing Considerations - Whaiwhakaaro-aa-oranga tonutanga

- 21. The purpose of Local Government changed on the 14 May 2019 to include promotion of the social, economic, environmental and cultural wellbeing of communities in the present and for the future ('the 4 wellbeings').
- 22. The subject matter of this report has been evaluated in terms of the 4 wellbeings during the process of developing this report as outlined below.
- 23. The recommendations set out in this report are consistent with that purpose.

#### Social

24. The recommendations included in this report helps the community achieve their goals by ensuring their safety while attending these events.

#### **Economic**

25. The proposed events all bring visitors into Hamilton City and support the local businesses in the vicinity of the events.

## **Environmental**

26. No specific environmental considerations were identified in the development of this report.

#### **Cultural**

27. No specific cultural considerations were identified in the development of this report.

#### Risks - Tuuraru

28. Although the games outlined above would still go ahead, due to the large numbers of people expected to attend, there are considerable public safety and accessibility risks associated with not approving the recommendations in this report.

# Significance & Engagement Policy - *Kaupapa here whakahira/anganui* Significance

- 29. Staff considered the following factor under the Significance and Engagement Policy:
  - the form of engagement used in the past for similar proposals and decisions.
- 30. Staff have considered the key considerations under the Significance and Engagement Policy and have assessed that the recommendation(s) in this report has/have a low level of significance.

## **Engagement**

- 31. In accordance with the Local Government Act provisions, public notification was given of the intention to consider the temporary road closures applications at this meeting.
- 32. Staff have undertaken consultation with the NZ Police and Waka Kotahi NZ Transport Agency (Waka Kotahi) and they are supportive of the temporary road closure for the events.
- 33. In addition, the applicants have provided notification to all properties in the sections of road closures.
- 34. If the closures are approved by this committee, a public notice of the decision to temporarily close the roads will be issued.
