On 24 June 2019 you made a request pursuant to the Local Government Official Information and Meetings Act 1987 for details of costs incurred in engaging City Safe Patrolling guards in 2019, 2018 and 2017.

Our records show:

	\$ 351,229.21	\$ 384,241.75	\$ 494,583.38

For completeness, we note City Safe staff are not 'guards', rather they operate as patrollers who display a high level of visibility and have a high level of engagement with all users of our public spaces. Their enhanced skill sets means that they are skilled at dealing with the homeless, those with addiction or mental health issues and use their de-escalation skills to prevent incidents from occurring.
