Hamilton City Council had 9(nine) Parking Warden positions for the 2018/2019 financial year with one of those positions being 30 hrs per week.

Total number of parking and stationary vehicle infringements (combined) issued for the 2018/2019 financial year 24,822.

Total value of parking infringements issued for the 2018/2019 financial year was \$1,874,723.
