Waterways

Further to your request received on 3 October 2019 regarding Waterways, please find below our response to your queries.

1. Request for any water testing that has been conducted by the Hamilton City Council in its waterways (including the Waikato River and Hamilton lake) where pollution levels have been deemed higher than safe from January 1 2016 until today. Could I please have this displayed in a table detailing when and where the test took place, the pollution level recorded, and how long the area was deemed unsafe.

Hamilton City Council undertakes a variety of routine monitoring programmes on waterways within the city including the Waikato River and Lake Rotoroa. Each programme is designed with a specific objective so a wide range of parameters are monitored.

Many of the parameters monitored as part of these programmes do not have any applicable national guidelines to indicate a level of being safe or unsafe. The only parameters we routinely monitor for with recognised recreational guideline levels specifically targeting public health safety in freshwater are E. coli (<550 MPN/100mL) and Algae biovolumes (<1.8 mm³/L of potentially toxigenic cyanobacteria). The relevant guidelines for these parameters are published by the Ministry for the Environment:

- Microbiological Water Quality Guidelines for Marine and Freshwater
- New Zealand Guidelines for Cyanobacteria in Recreational Fresh Waters (interim guidelines)

The attached spreadsheet contains E.coli monitoring results that Hamilton City Council has obtained as part of routine monitoring programmes. Details are shown where monitoring have exceeded the guideline E.coli level of 550 MPN/100mL during the period of 1 January 2016 until 3 October 2019. Where the spreadsheet is blank and carries no data, the result was below the guideline E.coli level. Where monitoring has exceeded the guideline, the area is deemed unsafe until monitoring indicates a safe level.

There have been no Algal biovolume monitoring results of samples taken from the Waikato River or Lake Rotoroa by Hamilton City Council since 1 January 2016 that have exceeded the Algae biovolume guideline level of 1.8 mm³/L.

2. Request for any records of when waste water has spilled into the Waikato River and Hamilton Lake from January 1 2016 until now. Can I please have this information in a table marking when and where these spills took place, the reason for the spill, and how much wastewater was discharged.

The table below summarises the details of any events in which untreated wastewater has been discharged directly to the Waikato River between 1 January 2016 and 3 October 2019.
