Please find **attached** the Operative District Plan map with the parcel of land Kainga Ora are proposing to develop in Flagstaff. Planning Guidance Unit are yet to receive a resource consent application for this site.

The site is the block of land immediately south of Flagstaff Park identified with a 'white colour' which reflects a General Residential Zone, and adjoins a Business Zone to the west (blue) and a Community Facilities Zone to the east (purple). The subject site has been marked out on the attached map.

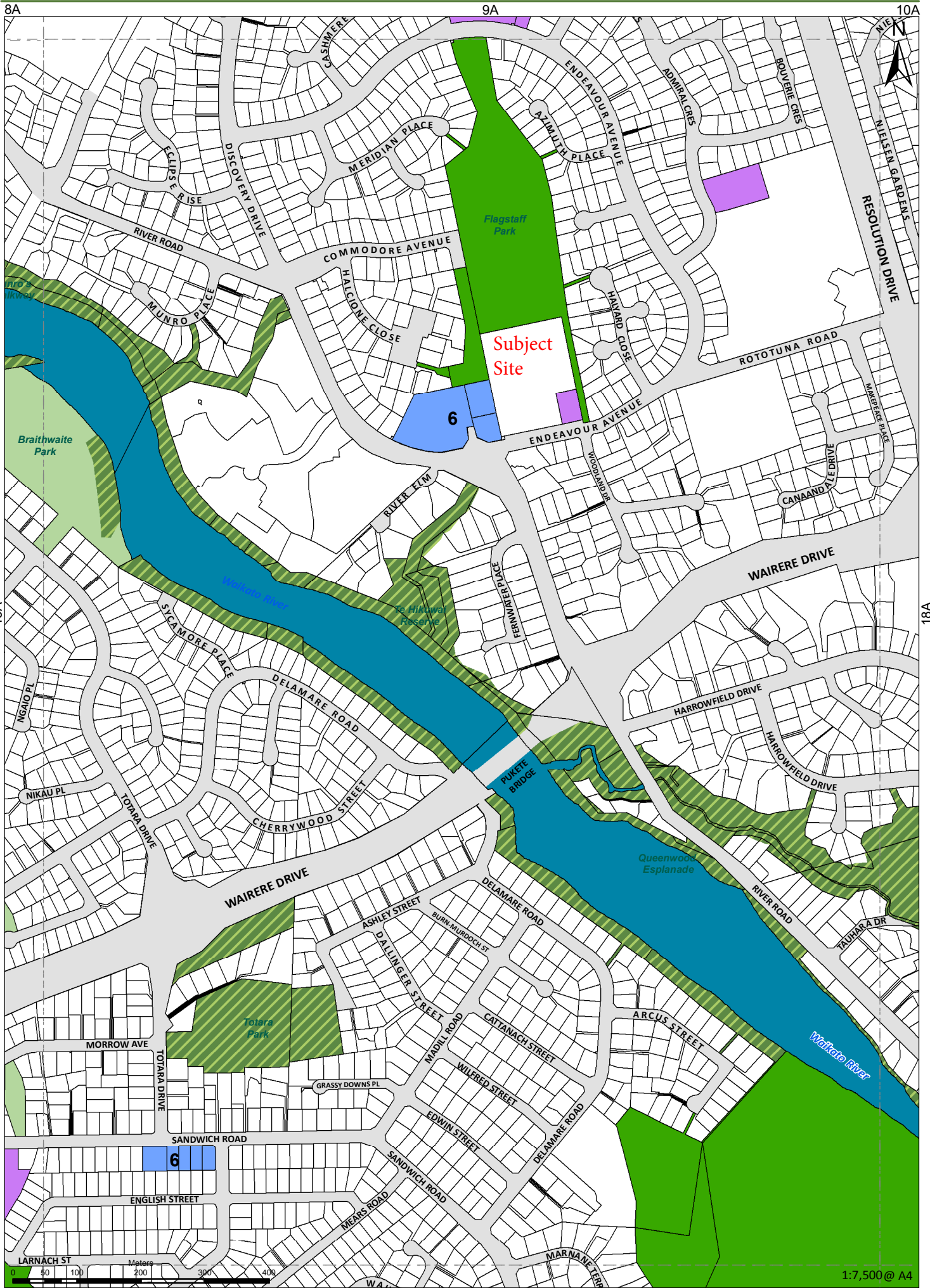
